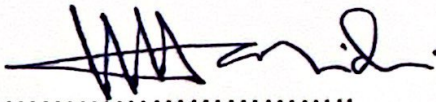
STATEMENT OF OFFENCE

PARTICULARS OF OFFENCE

JENNIFER BILIKWIJA JOVIN @NIFFER, on diverse dates between 1st August, 2025 to 24th October 2025, in various places within Dar Es Salaam Region, being under allegiance to the United Republic of Tanzania, while in the United Republic of Tanzania, formed an intention to persuade the public to effect the obstruction of the 2025 General election, for the purpose of intimidating the Executive of United Republic of Tanzania and manifested such intention by encouraging the general public to purchase tear gas masks from her business centre so as to protect themselves from police tear gas during unlawful demonstration aiming to obstruct the said 2025 General election.
